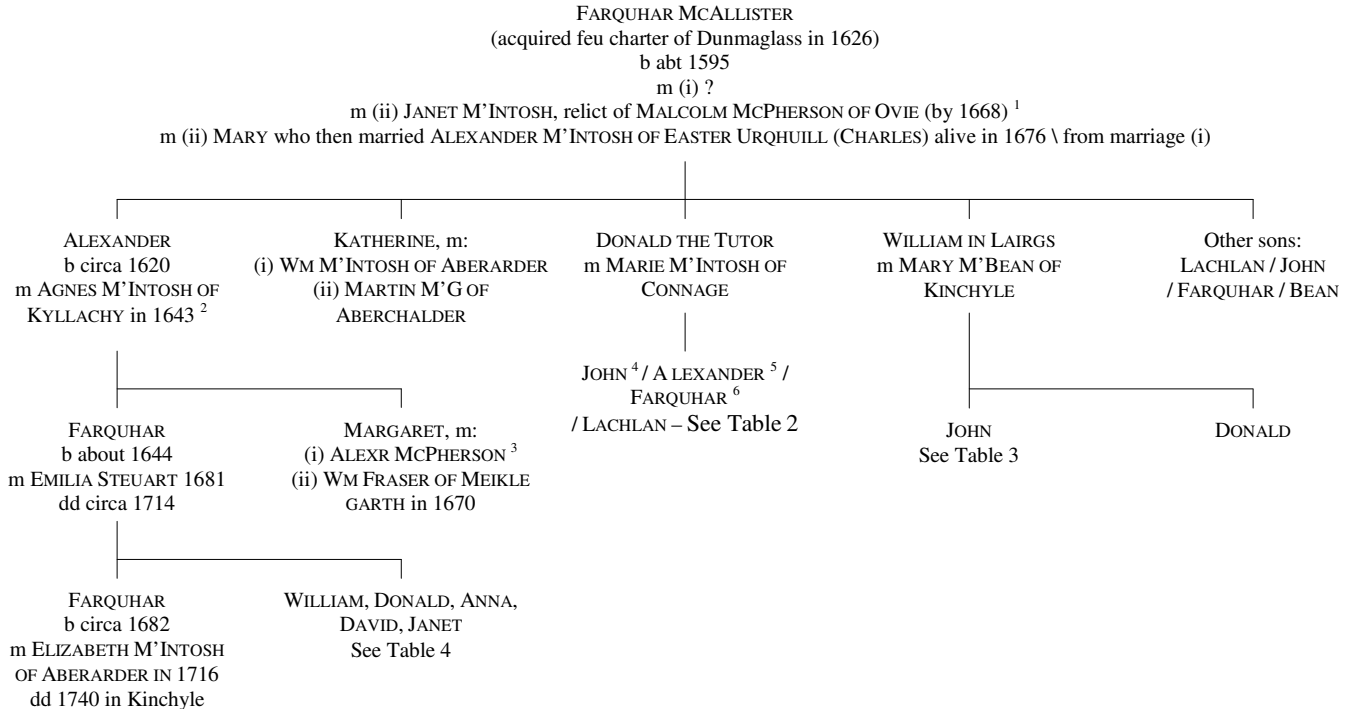


## PEDIGREE TABLES

## TABLE 1: THE DUNMAGLASS FAMILY IN THE 17<sup>TH</sup> CENTURY



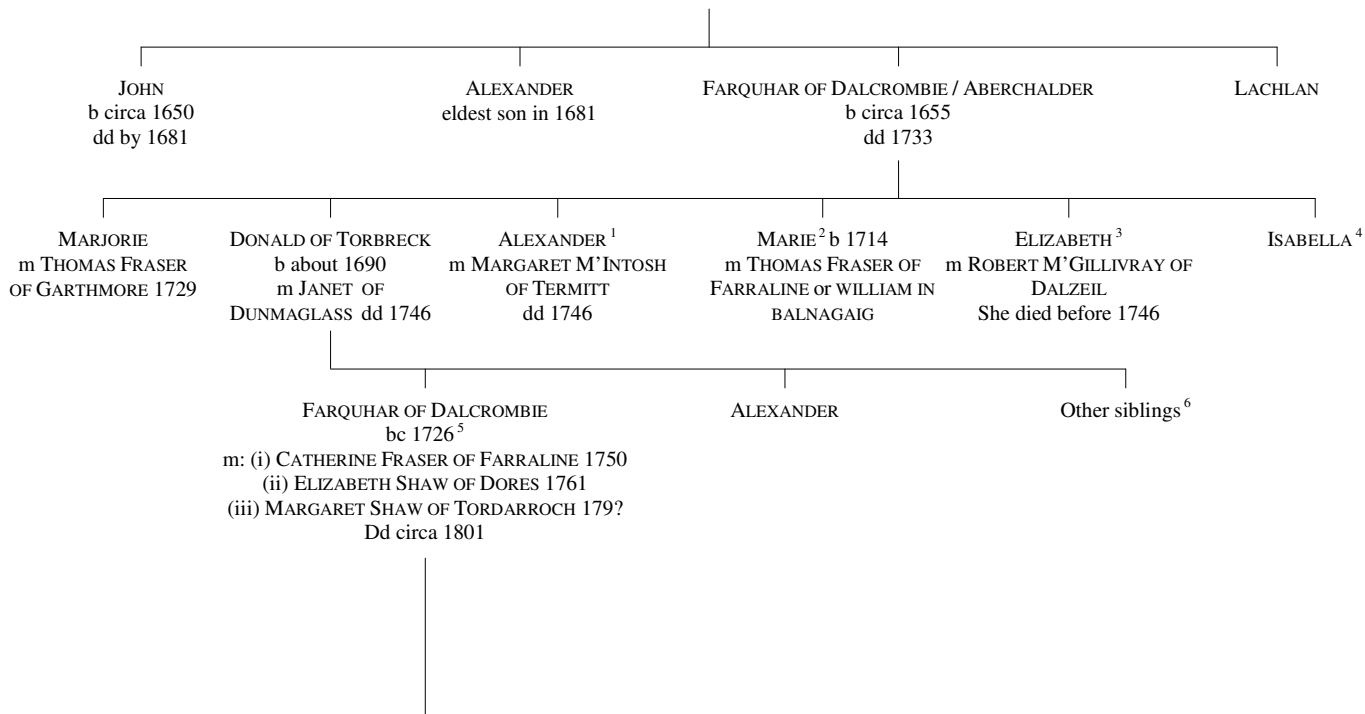
- (1) McPherson Muniments, NAS, Edinburgh. Dr. Alan G. Macpherson believes that she was probably past child-bearing age at the time of this marriage.
- (2) After Alexander's death, Agnes married secondly William Forbes of Skellater, with issue. (One son, said to have been born about 1644, John Forbes of Inverernan, died a prisoner in Carlisle.) Alexander must therefore have died soon after his marriage.
- (3) Sir Aeneas McPherson's Genealogy of the McPhersons shows she married Alexander McPherson, brother of Malcolm of Crubenmore and Breakachie (Dr. Alan G. Macpherson). The Farr MS states she married Fraser of Meikle Garth.
- (4) Eldest son in 1670
- (5) Eldest son in 1681
- (6) Title: Portioner of Dalcrombie or of Aberchalder

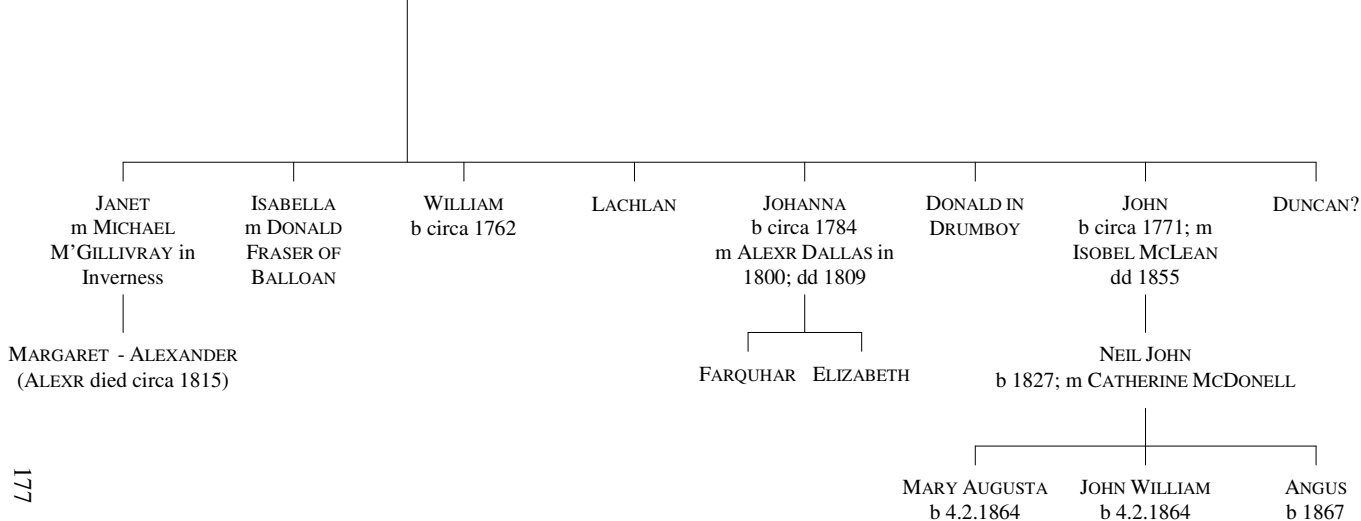
Note:

One of the earliest M'Gillivray wills is that of an Agnes Neyn James vick phail vick Conachy, given up in 1676 by her husband Alexander M'Gillivray in Dunmaglass. This Agnes is presented in the litigation papers as being the wife of Alexander of Dunmaglass, but this does not seem possible as Alexander is reportedly deceased some thirty years earlier. This Alexander's mother is named as Euphan Steuart, and he has a brother John.

## TABLE 2: THE M'GILLIVRAYS IN LONNIE AND CANADA

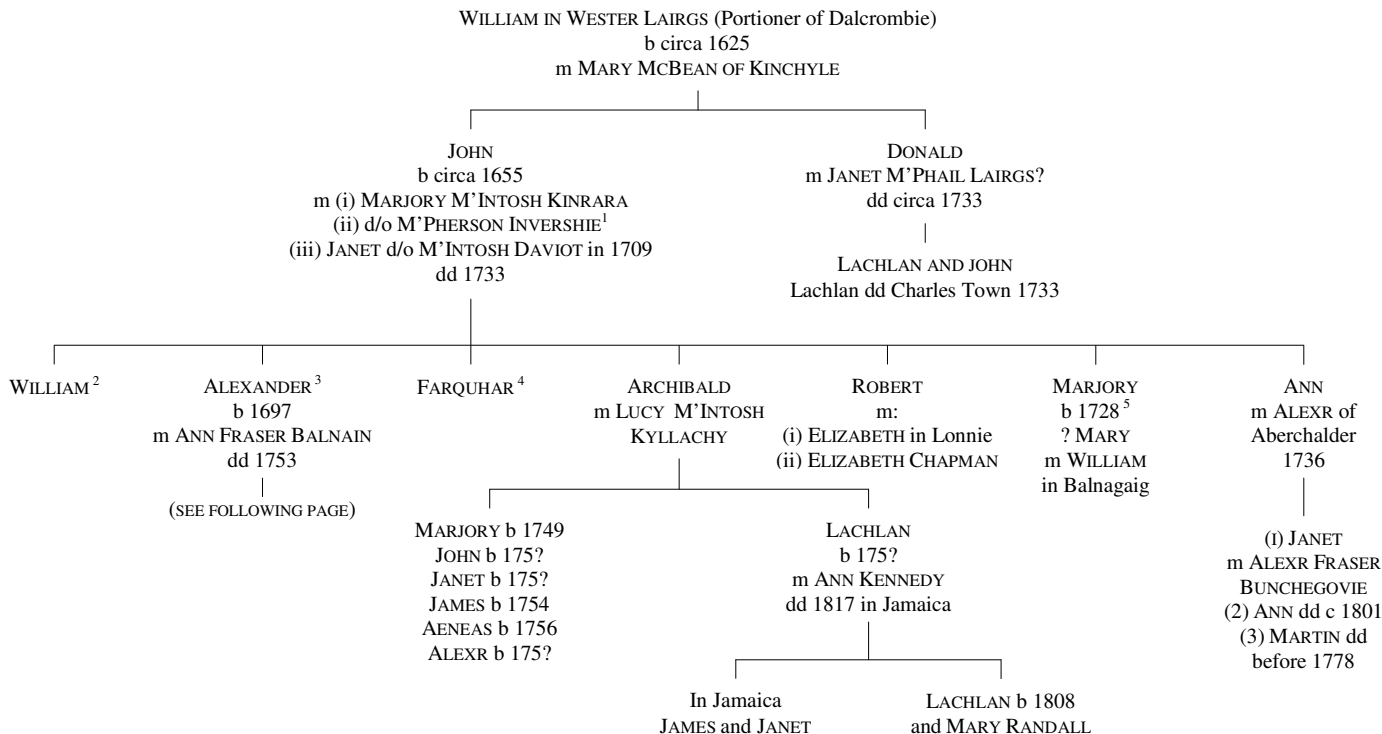
DONALD THE TUTOR (Portioner of Dalcrombie)  
b abt 1623; m MARIE M'INTOSH OF CONNAGE; dd by 1676



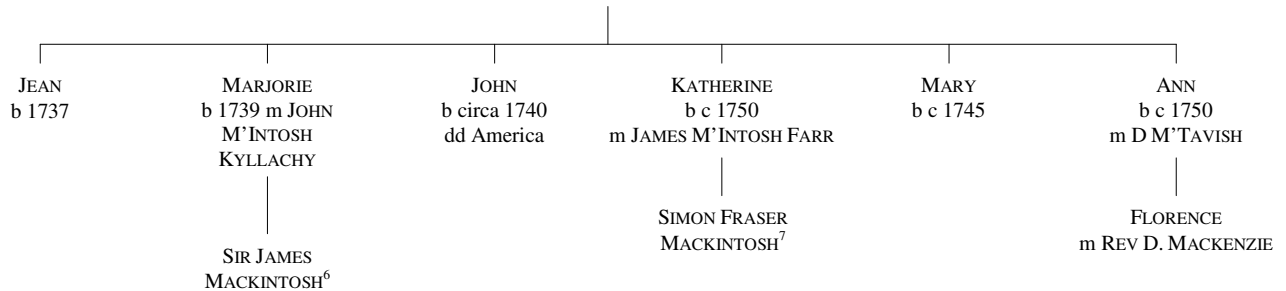


- (1) The names of any issue are not known
- (2) Marie's birth is registered in the parish records. A Mary, 'daughter to Dalcrombie' married Thomas Fraser of Farraline in Dunlichity in 1747 (OPR). This may not be the correct Dalcrombie family.
- (3) Elizabeth died shortly afterwards; Robert remarried Elizabeth Chapman and a daughter served heir to her mother circa 1805
- (4) Farr MS gives session records as source for her death in 1709
- (5) Farr MS states he joined the 1745-6 rebellion aged 19, putting his date of birth at 1726-7
- (6) One daughter married a Mr. Grant

TABLE 3: THE M'GILLIVRAYS IN DALZEIL, AMERICA AND JAMAICA

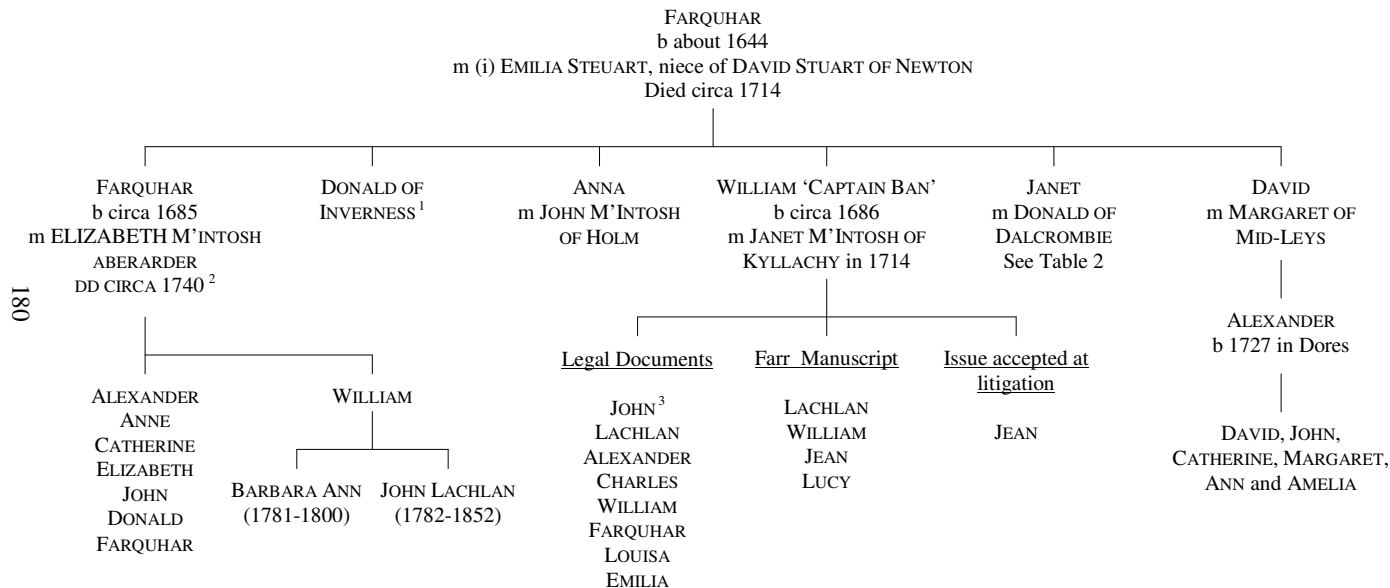

- (1) According to descendant, father of Alexander married a daughter of M'Pherson of Invereshie (See Table 5)
- (2) Eldest son in 1709
- (3) Eldest son in 1731. Robert was his brother-german
- (4) Witness in 1717 and 1721
- (5) Her baptism is in the OPR
- (6) Two siblings
- (7) Tenth child

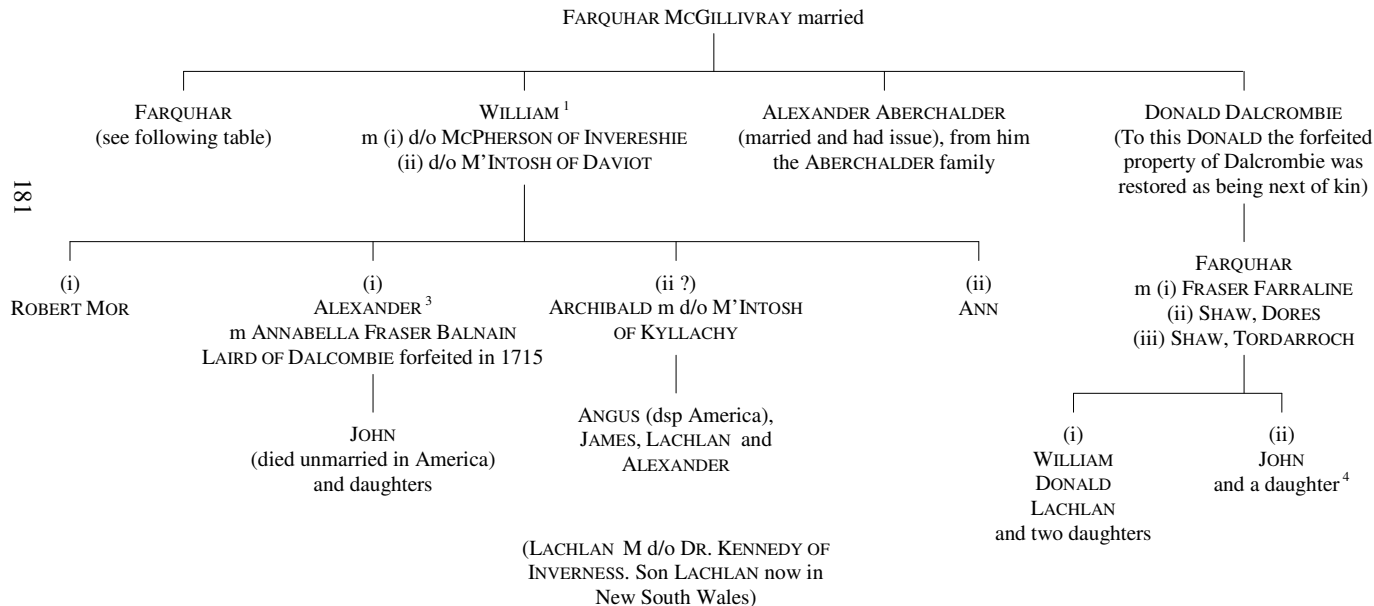
TABLE 4: THE DUNMAGLASS FAMILY IN THE 18<sup>TH</sup> CENTURY



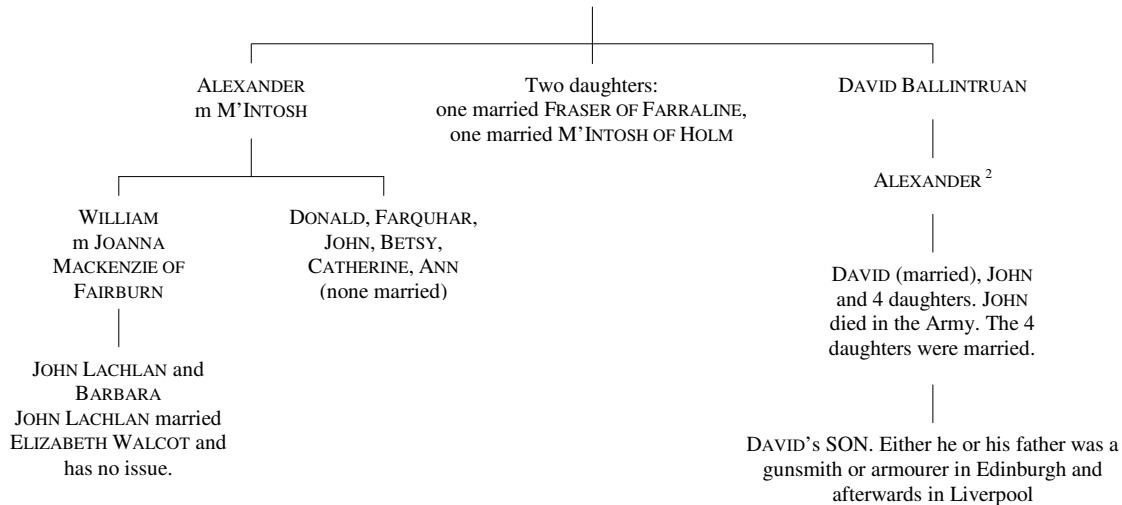
- (1) Donald had at least one daughter, Janet, as per the 1747 Inverness Deaths register
- (2) Farquhar also had a natural daughter with Katherine Ross: Jean born in 1712 (she would not have been of child-bearing age when Jean Roy's daughters were born)
- (3) Natural son John M'Gillivray; he married Isobel Fraser, SC29/10/420

The following has been noted at the bottom of the page: Copy Genealogical tree of the MacGillivrays of Dunmglass made up by the Revd. Duncan Mackenzie, Episcopal minister at Tullich, Strathnairn, from the information of his mother in law, Mrs. McGillivray or McTavish, who was born at Fort Augustus and died at Brin Cottage, and of her daughter, his own wife. The original is marked on the back thus: 'To be kept safe, 1849 (signed) D. McKenzie'

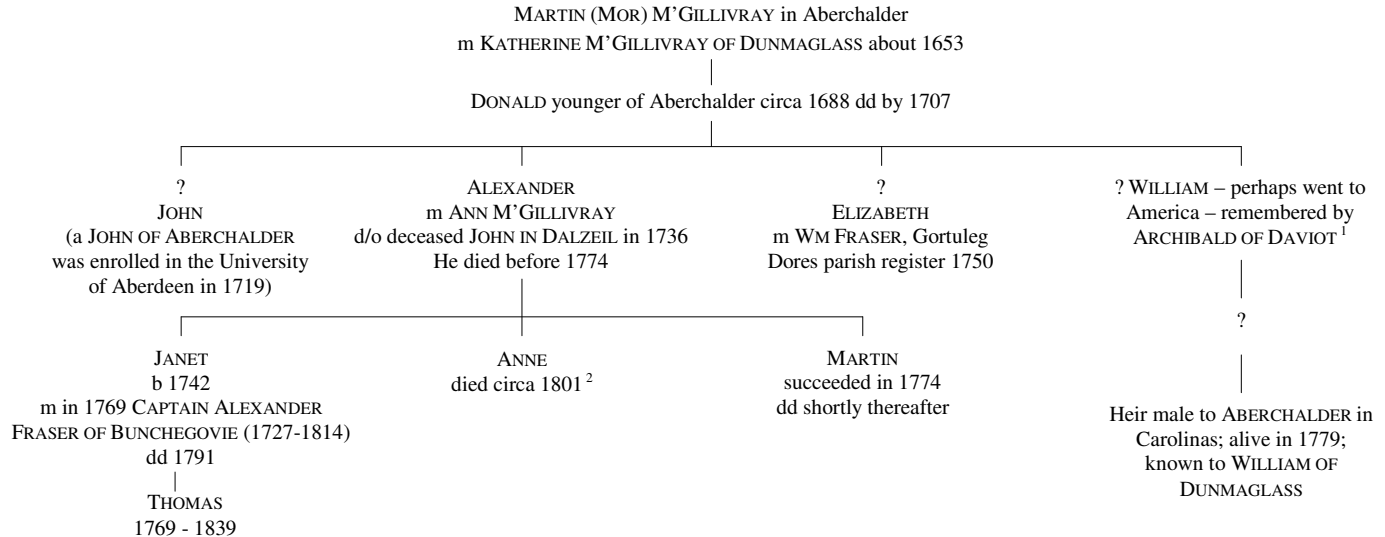
Rev. Mackenzie writes:

- (1) William married a daughter of Invereshie and had issue (i) Robert Mor who was killed at the battle of Culloden while leading on the M'Intosh Regiment (unmarried) and (ii) Alexander. Married 2dly a daughter of M'Intosh of Daviot, issue Archibald and Ann. (author's note: Robert's role at Culloden was also misreported by *The Inverness Courier* in the 19<sup>th</sup> century)
- (2) The Rev. D. Mackenzie's wife recollects to have seen this Alexander at Balintruan where he died
- (3) Alexander was the laird of Dalcrombie until his estate was forfeited in 1715. The property was restored to Donald, 3rd son of Farquhar chief, being the next of kin. This Alexander, by his daughters, was grandfather of the present Colonel Mackintosh of Farr and of the Revd Duncan Mackenzie's wife
- (4) It is believed all the issue of the above parties (i.e. from this line of Dalcrombie) are now extinct.

Author's notes:

- a) The further up the tree, the more inaccurate these genealogies clearly become, not matching archived deeds. However, note the inexplicable absence of William, the Captain Ban, Lachlan, Indian trader, and Jean. The latter two were alive during John Lachlan's childhood.
- b) Note this table shows that the Ballintruan family is heir to Dunmaglass, or failing, Rev. Lachlan.
- c) Note Alexander in Knocknagaeil has McPherson ancestor (Invereshie): there is a 1727 marriage in the Petty register of Alexander M'Gillivray in Dalzeil to a Margaret McPherson in mid-Coul. Perhaps a first marriage?

## TABLE 6: THE M'GILLIVRAYS OF ABERCHALDER



- (1) For possible Williams in Carolina, consult *The McGillivray and McIntosh Traders on the Old Southwest Frontier, 1716-1815* by Amos Wright. This may not be the right position for William ; he could be brother or nephew of Donald.
- (2) Anne's heirs were: a) Alexander M'Gillivray in Daviot, her maternal cousin b) Alexander M'Gillivray coppersmith (husband of Marjory, Lachlan's niece) c) Donald Roy M'Gillivray in Dalscoilt who may have been another maternal cousin and b) Lt John and Mrs Ann Fraser in Errogie. Her nephew Thomas Fraser would inherit Alexander in Daviot's portion if the latter died before Anne.

Note: Farquhar of Aberchalder (grandfather of Farquhar of Dalcrombie) took the name Aberchalder not because he was a member of this family but because he had a legal lien on the property at the beginning of the 18<sup>th</sup> century.
